

## **OPERATING INSTRUCTION**

#### POWER SUPPLY

## DC (battery) Operation

Insert 2 batteries, type AA cells (not included) into battery compartment and then close the compartment door.

#### Note:

Check your batteries regularly. Old or discharged batteries should be replaced. If the unit is not to be used for sometimes, remove batteries from the battery compartment to avoid leakage.

### Normal Operation

- Select FM or AM wave band by switching RADIO BAND SELECTOR.
- 2. Adjust the sound level with using VOLUME.
- 3. Tune to a radio station with using TUNING.

## To improve reception:

- For FM, pull out the telescopic aerial. To improve FM Reception incline and turn the aerial, reduce its length if the FM-signal is too strong (very close to a transmitter).
- For AM, the set is provided with a built-in aerial, so there is no need to use the telescopic aerial. Turn the set to find the best position.

### Aux-out

You may connect headphone (not included) to 3.5mm **HEADPHONE JACK**. The loudspeaker is then muted. **Avoid listening to headphones at high volume levels**



## **EN** Warranty conditions

### Warranty card is not a part of the device packaging.

This product is warranted for the period of 24 months from the date of purchase to the end-user. Warranty is limited to the following conditions. Warrantu is referred only to the customer goods using for common domestic use. The claim for service can be applied either at dealer's shop where the product was bought, or at below mentioned authorized service shops. The end-user is obligated to set up a claim immediately when the defects appeared but only till the end of warrantu period. The end user is obligated to cooperate to certify the claiming defects. Only completed and clean (according to hugienic standards) product will be accepted. In case of eligible warrantu claim the warrantu period will be prolonged by the period from the date of claim application till the date of taking over the product by end-user, or the date the end-user is obligated to take it over.
