### **DAILY USE**

# INSTALLATION IMPORTANT!

- FOR ELECTRICAL CONNECTION CAREFULLY, FOLLOW THE INSTRUCTIONS GIVEN IN THIS MANUAL. UNPACK THE APPLIANCE AND CHECK IF THERE ARE DAMAGES ON IT.
- DO NOT CONNECT THE APPLIANCE IF IT IS DAMAGED. REPORT POSSIBLE DAMAGES IMMEDIATELY TO THE PLACE YOU BOUGHT IT. IN THIS CASE RETAIN PACKING.
- IT IS ADVISABLE TO WAIT AT LEAST FOUR HOURS BEFORE CONNECTING THE APPLIANCE TO ALLOW THE OIL TO FLOW BACK IN THE COMPRESSOR.
- ADEQUATE AIR CIRCULATION SHOULD BE AROUND THE APPLIANCE, LACKING THIS LEADS TO OVERHEATING. TO ACHIEVE SUFFICIENT VENTILATION, FOLLOW THE INSTRUCTIONS RELEVANT TO INSTALLATION.
- WHEREVER POSSIBLE THE BACK OF THE PRODUCT SHOULD NOT BE TOO CLOSE TO A WALL TO AVOID TOUCHING OR CATCHING WARM PARTS (COMPRESSOR, CONDENSER) TO PREVENT THE RISK OF A FIRE, FOLLOW THE INSTRUCTIONS RELEVANT TO INSTALLATION.
- THE APPLIANCE MUST NOT BE LOCATE CLOSE TO RADIATORS OR COOKERS.

- THE APPLIANCE MUST BE CONNECTED TO A SOCKET WITH THE APPROPRIATE VOLTAGE AND A CORRECTLY INSTALLED FUSE SOCKET.
- THE REFRIGERATOR I FREEZER MUST NOT BE PLACED OUTDOORS OR EXPOSED TO RAIN.
- THE REFRIGERATOR I FREEZER MUST BE LOCATED AT LEAST 50CM FROM HEATERS, ELECTRIC OVENS, GAS OVENS, ETC.
- IF THE REFRIGERATOR WITH FREEZER IS LOCATED NEXT TO THE FREEZER, THERE MUST BE A MIN. 2CM SPACING.
- DO NOT PLACE HEAVY OBJECTS ON THE REFRIGERATOR / FREEZER, DO NOT COVER IT.
- ABOVE THE FRIDGE / FREEZER THERE MUST BE A MIN. 150MM FREE SPACE.

### **PART 2: DESCRIPTION OF THE APPLIANCE**

### View of the appliance



- 1. Electronic temperature regulator
- 2. Decorative board (some models have)
- 3. Storage shelf
- 4. Crisper cover
- 5. Crisper
- 6. Adjustable feet
- 7. Egg tray
- 8. Door handle (some models have)
- 9. Upper door rack
- 10. Door
- 11. Lower door rack

### NOTE!


Due to continual modification of our products, your refrigerator may be slightly different from this instruction Manual, but its functions and usage methods remain the same.

### Note:

 Cooling section (fridge) - The most efficient use of energy is ensured by the configuration with drawers in the lower part of the appliance and shelves evenly distributed. The direction of door opening does not affect energy consumption.

### **PART 3: DISPLAY CONTROL**

Use your appliance according to the following guidelines, your appliance has functions as control panel shown in the pictures below.



### Controlling the temperature

We recommend that when you start your refrigerator for the first time, the temperature for the refrigerator is set to 4°C. If you want to change the temperature, follow the instructions below.

### CAUTION!

When you set a temperature, you set an average temperature for the whole refrigerator cabinet. Temperatures inside each compartment may vary from the temperature displayed on the panel, depending on how much food you store and where you place them. Ambient temperature may also affect the actual temperature inside the appliance.

### 1. Fridge

Press the middle part of button to set fridge temperature between 2°C and 8°C as needed, and control panel will display corresponding figures according to the following sequence.

### 2. Super Cool

If want to lock in vitamins and nutrients offresh food and keep food fresh longer, Super Cool will quickly lower the temperature within the refrigerator compartment, so food will cool faster. You can put the food in the refrigerator first, and then use the Super Cool function.

Temp.

2 3sec Press the middle part of button for 3 seconds to activate the Super Cool function.

The light will be on. Press the middle part of button for 3 seconds to cancel the super cool function.

Super cool automatically switches of after 6 hours and then the refrigerator temperature setting will revert back to the previous setting.

### **PART 4: FIRST USE AN INSTALLATION**

### Cleaning before use

Before using the appliance for the first time, wash the interior and all internal accessories with lukewarm
water and meutral soap in order to remove the typical smell of a brand new product, then dry thoroughly.

### **Installation Positioning**

### WARNING!

Before installing, read the \* instruction carefully for your safety and the correct operation of appliance.

- · Position the appliance away from sources of heat such as stoves, radiators, direct sunlight, etc.
- Maximum performance and safety are guaranteed by maintaining the correct indoor temperature for the class of unit concerned, as specified on the rating plate.
- This appliance performs well from SN to T. The appliance may not work properly if it is left for a longer period at a temperature above or below the indicated range.


Acronym for ambient temperature range, ie SN, N, ST or T, in determining cli mate classes:

- 1. the extended temperate zone (SN) has a temperature range of 10°C to 32°C;
- 2. the temperate zone (N) has a temperature range of 16°C to 32°C;
- 3. the subtropical zone (ST) has a temperature range from 16°C to 38°C;
- 4. the tropical zone (T) has a temperature range of 16°C to 43°C.

### **IMPORTANT!**

It is necessary to have good ventilation around the fridge to allow for the dissipation of heat. For this reason, sufficient clear space should be available around the appliance. It is advisable for there to be 50-70mm separating the back of the fridge to the wall at least 100mm of space on its two sides and a clear space in front to allow the doors to open 160°.

Appliances must not be exposed to rain. Sufficient air must be allowed to circulate in the low rear section
of the appliance, as poor air circulation can affect performance. Built-in appliances should be positioned
away from heat sources such as heaters and direct sunlight.



### Installing the rubber supporting


 Screw provided in a plastic bag with your appliance, you can install these accessories according to the following procedure.

### NOTE:


There is no need to install these accessories under normal usage.

Only under the extreme circumstances, cabinet empty while load on door with total mass of 15 kg and opening the door about 90 degree .this refrigerator may take risk of tipping. Then rubber supporting pad should be fastened to the lower base cover to steady this appliance.


1. Tilt appliance to find screw hole on the left of lower base cover.



2. Put screw into the hole of rubber supporting pad.



3. Make screw in alignment with the hole on lower base cover. Fasten rubber supporting pad to the base cover firmly by a cross screw driver (self-provided).



### Leveling

• The appliance should be level in order to eliminate vibration. To make the appliance level, it should be upright and both adjusters should be in stable contact with the floor. You can also adjust the level by unscrewing the appropriate level adjustment in the front (use your fingers or a suitable spanner).


### Accessories 1)

### Movable shelves/trays

- Various glass, plastic storage shelves or wire trays are Included with your appliance different models have different combinations and different models have different features.
- The walls of the refrigerator are equipped with a series of runner so that the shelves can be positioned as
  desired.


### Remove door rack

Hold the left side of the door rack, inward- press the other side and lift this side until it separated from the liner. Then you can take out the door rack from the liner.



### Installation door rack

First, install the left of the door rack. Second, inward-press the other side and downward-press this side until installation it.



### Crisper

• For storing fruit and vegetables.

### Refrigerator compartment 2)

- For storing the food that does not need to be frozen and different sections suitable for different kinds of food.
- 1) If the appliance contains related accessories and functions.
- 2) If the appliance contains a freezer compartment

### **PART 6: HELPFUL HINTS AND TIPS**

### **Noises during operation**

**Clicks** - Whenever the compressor switches on of off, a click can be heard.

**Humming** - As soon as the compressor is in operation, you can hear it humming.

**Bubbling** - When refrigerant flows into thin tubes, you can hear bubbling or splashing noises.

Splashing - Even after the compressor has been switched off, this noise can be heard for a short time.

### **Energy saving tips**

- Do not install the appliance near stoves, radiators or other sources of warmth.
- Keep the time the appliance is open to a minimum.
- Do not set the temperature colder than necessary.
- Make sure the side plates and back plate of the appliance are at some distance from the wall, and follow
  the instructions relevant to installation.
- If the diagram shows the correct combination for the drawers, crisper and shelves, do not adjust the combination as it would produce an effect on energy consumption.

### Hints for fresh food refrigeration

- Do not store warm foods or evaporating liquids in the appliance.
- Do cover or wrap the food, particularly if it has strong flavor or odor.
- Position food so that air can circulate freely around it.

### Hints for refrigeration

- Meat (all types): wrap in polyethylene (plastic) bags and place on the glass shelf above in this way only on
  or two days at the most.
- Cooked foods, cold dishes, etc...: these should be covered and may be placed on any shelf.
- · Fruit and vegetables: these should be thoroughly cleaned and placed in the special drawer provided.
- Butter and cheese: these should be placed in aluminum foil or polyethylene (plastic) bags while removing as much air as possible.
- Milk bottles: theses should have a cap and should be stored in the bottle rack on the door.

### **Replacing LED lighting**

If your refrigerator has LED lighting contact the help desk as this should be changed by authorized personnel only.

This product contains a light source with energy efficiency class G.

### **PART 7: CLEANING AND CARE**

### **Cleaning and care**

For hygienic reasons, the appliance interior, including interior accessories, should be cleaned regularly. The appliance should be cleaned and maintained at least every two months.

### **WARNING!**

### Danger of electrical shock!

The appliance should not be connected to the main power supply during cleaning. Before cleaning, switch
the appliance off and remove the plug from the main power supply, switch off, or shut off the circuit
breaker of fuse.

### Notice!

- · Remove the food from the appliance before cleaning. Store them in a cool place and keep well covered.
- · Never clean the appliance with a steam cleaner. Moisture could accumulate in electrical components.
- Hot vapors can lead to the damage of plastic parts.
- Ethereal oils and organic solvents can attack plastic parts, e.g. lemon juice or the juice from an orange peel, butyric acid, or cleansers that contain acetic acid.
- · Do not use any abrasive cleansers.
- Clean the appliance and the interior accessories with a cloth and lukewarm water. Commercially available
  dish washing detergents may also be used.
- · After cleaning, wipe with fresh water and a clean dish cloth.
- Accumulation of dust at the condenser increases energy consumption; clean the condenser at the back of the appliance once a year with a soft brush or a vacuum cleaner.(Only for the outside-condenser product)
- Check the water drain hole on the rear wall of the refrigerator compartment.
- Clear a blocked drain hole with the aid of something like soft green peg, an be careful not to create any damage to the cabinet by sharp objects.
   After everything is dry, the appliance back into service.

### **Defrosting**

### Defrosting in the fresh food storage compartment

• Water from the defrosting option will automatically be drained into a drip tray through a drain pipe at the back of the appliance.

### Taking the appliance out of service

- · Empty the appliance
- · Pull out the power plug
- · Clean thoroughly (see section: Cleaning and Care).
- · Leave the door open to prevent odours.

### **PART 9: REVERSING THE DOOR**

The side in which the door opens can be changed from the right side (as supplied) to the left side, if the installation site allows for it. Tools you will need:

1. 8mm socket driver



2. 10mm socket driver



3. Cross-sharped screwdriver




4. Putty knife or thin-blade screwdriver




Before you begin, place the fridge on it's back in order to gain access to the base, you should rest it on soft foam packaging or similar material to avoid damaging the cooling popes at the rear of the fridge.

### Reverse the door

1. Stand the fridge, remove the two screws on the back of the top cover, then lift the top cover and place it on a padded surface to prevent scratching.




2. Remove the four screws as follow diagram. Lift the upper hinge core .then put it in a safe place.




3. Lift the door and place it on a padded surface to prevent scratching. Remove both adjustable feet and remove the bottom hinge bracket by unscrewing the bolts. Then transfer them to another side.

### NOTE:


- 1. You need move hinge axis from hole ① to ② before transfer.
- 2. You need install the rubber supporting on the side which haven't hinge.



4. Set the door into its new place making sure the pin enters the bushing at the lower frame section. Replace the lid by fitting the upper hinge core into the upper door's hole, securing it with the 2 screws. Replace another 2 screws to another side.



5. Put the top cover in the freezer. Tighten the 2 screws on the back of top cover.





When changing the side at which the door opens, the appliance must not be connected to the mains. Remove plug from the mains beforehand.


### **PART 10: INSTALLING THE DOOR HANDLE**

If there is door handle separately provided in a plastic bag with your appliance, you can install it as follows.

1. Remove the screw on the door. Keep or install the screw covers on the side which have hinge.



2. Match the handle hole to the door, then fix the screw which you removed from the door to make the handle fixed firmly on the door.

### Placement of food in the appliance

- Potatoes, onions and garlic should not be stored in the refrigerator / freezer.
- Under normal circumstances, the temperature setting in the refrigerator is sufficient to + 4 °C.
- The temperature of the refrigerator should be between 0 °C and 80 C. Fresh foods stored below 0 °C freeze, rot. The bacterial load increases when stored above 8 °C and food spoils.
- Do not put warm or hot food in the fridge / freezer, wait for it to cool to room temperature. Hot food raise
  the temperature inside the refrigerator / freezer and can cause unnecessary spoilage and possible food
  poisoning.
- Meat, fish, etc. should be stored in a designated refrigerated compartment if available.
- Fruits and vegetables should be stored in a designated refrigerated compartment if available.
- To prevent contamination of meat products with bacteria, do not store fruits and vegetables in a common compartment. The same is true in reverse contamination of fruits and vegetables with bacteria from meat products.
